**SUNBELT CLASS ACTION SETTLEMENT
CLAIM FORM**

- To qualify for any award, you must have purchased one or more of the following services in connection with equipment rental transaction documented on Sunbelt’s Rental Out form, which form/contract was dated during the Class Period. More specifically, during the Class Period, you must have purchased and paid for at least one:
 - **Pay on Return Refueling Charge**, itemized on your invoice as “2141XXX000” and “Diesel”, “Gas”, “Propane”, or “Kerosene”.
 - Excluded: This does not include any charges for other types of fuel services, such as refueling equipment on a job site, fuel delivery, fuel monitoring, etc., even if coded on your invoice with the descriptions quoted above.
 - **Transportation Surcharge**, itemized on your invoice as “DLPKSRCHG Transportation Surcharge”.
- The **Class Period** includes contracts dated 12/29/2013 – 11/10/2015 for all stores within the United States, except as separately stated below:
 - 12/16/2013 – 11/10/2015 for stores located in Arizona, California, and Nevada.
 - 12/8/2011 – 11/10/2015 for stores located in Miami-Dade County, Florida
 - 7/21/2011 – 11/10/2015 for stores located in Georgia
- The award is not intended to provide any compensation for any Refueling Charges or Transportation Surcharges for which you were reimbursed by another person. Do not submit a claim form for those charges (in such event, please forward the form to the person or entity that reimbursed you for the charges or contract the Administrator). The Claim Form may be subject to audit, verification and court review.
